AurGroup Offers Instant Issue Debit Cards

#### What is an Instant Issue Debit Card?

A debit card that AurGroup issues the day a member opens a new checking account or reports a lost/stolen debit card. You take the card with you, and it's ready for activation the next day.

#### How does it work?

AurGroup has the capability to personalize a debit card at the branch and assign a personal identification number (PIN). The debit card is smooth – not embossed – and it works exactly like a card you would receive through the mail.

#### How does it help me?

Instead of waiting for a new card to come in the mail, AurGroup issues a debit card the day you visit us. Because our members depend on their debit cards, an instant issue system allows for even more convenient banking.

## **Text Message Scams Are on the Rise**

Many of us have signed up for them: Text alerts that a package delivery is on its way or a notification about suspicious bank activity.

These convenient communication streams also make you more vulnerable to scams that hope you'll reply or tap a link. Once you do, the scammer can request sensitive information or download malware that steals it automatically - potentially giving them access to your bank accounts or other personal details for identity theft.

Watch out for these common text scams:

• Package Delivery: USPS warns that people are getting "package failed to deliver" texts with a link urging the individual to resolve the issue. Don't click on it. Instead, go to the USPS website and manually enter your tracking code.

- Bank Fraud Alerts: Sophisticated robotexts are posing as banks and credit unions alerting people about suspicious activity. Don't engage. Instead, call AurGroup directly. We will never text or email to ask for your personal information.
- Student Loan Debt Forgiveness: Government entities will not text you regarding your student debt. Visit your loan provider account directly for messages and information.
